COVID-19 activity in Marin:

Marin Confirmed Cases: **131** (11.01% increase from yesterday)

Tracking the total number of visits and those due to respiratory illnesses provides a situational awareness of current resource needs in our community, which helps advance policies to limit community spread and support our excellent healthcare partners' capacity to respond. Public Health Releases Guidance on Face Coverings

In response to new guidance from the California Department of Public Health, the <u>Marin County Department of Health and Human Services</u> (HHS) and <u>Bay Area health officials are recommending</u> that residents cover their nose and mouth when leaving home for essential travel, such as doctor appointments, grocery shopping or pharmacy visits.

Resident face coverings do not have to be hospital grade but need to cover the nose and mouth. Home-sewn fabric coverings, bandanas, a "DIY" mask from an old t-shirt and neck gaiters are examples of acceptable face coverings, especially because they can be washed and worn again.

Due to the global demand for personal protective equipment (PPE), there is a severe shortage of PPE across the state. Local officials are prioritizing acquisitions of PPE for healthcare workers on the frontlines of the COVID-19 pandemic. Marin HHS asks residents to refrain from purchasing PPE for their own use and to utilize homemade face coverings instead.

Call for Donations

If you have excess inventory of PPE to you wish to donate to support our health care and first responder workers, please fill out our

form. In addition, donations can be dropped off Monday - Friday, 1:00pm to 4:00pm, at The Salvation Army (351 Mission Avenue, San Rafael), who is collecting on behalf of Marin County Office of Emergency Services.

Only donations of new, unopened boxes of N95 masks, surgical masks, isolation masks, disposable gowns, and latex gloves will be accepted at this time.

We are seeking donations from those who have **excess inventory**. Please do not purchase PPE to donate. Individuals should not empty their disaster kits, so if you only have a small box or a couple of unused masks, please keep those items. Finally, we are unable to accept handmade masks, so keep those items to use on your own. If you do not have PPE to donate but still wish to help, consider donating to Marin Community Foundation's <u>COVID-19 Relief Fund</u>.
