Tracking the total number of visits and those due to respiratory illnesses provides a situational awareness of current resource needs in our community, which helps advance policies to limit community spread and support our excellent healthcare partners' capacity to respond. Marin School campuses closed for the remainder of school year

Marin County has aligned with six Bay Area county health officers and county superintendents of schools to make a unified, <u>regional decision to extend school closures</u> through the end of the school year. All schools will continue to provide instruction through distance learning.

Alameda, Contra Costa, Marin, San Mateo, Santa Clara, and San Francisco counties agreed to this decision for the health and safety of our communities at large. The decision follows statements by Governor Gavin Newsom and State Superintendent of Public Instruction Tony Thurmond suggesting that California's students would not likely be able to return to campus for in-person learning for the remainder of this school year.

In addition to providing student instruction through distance learning, school districts will continue to distribute school meals and provide child care for health care workers and essential workers as determined by local needs.

Surge preparation throughout Marin County

As <u>COVID-19</u> cases continue to climb in the Bay Area, the <u>Marin County Department of Health and Human Services</u> (HHS) and local health care providers are positioned to respond to increased demands on Marin's hospital system, including significant hospital surge.

Currently, hospitalizations from COVID-19 and similar respiratory illnesses are within Marin's hospital bed capacity. However, scientific modeling

predicts a continuous increase of COVID-19 cases, creating potential surge over the next two to six weeks. Hospital surge is the point during a significant emergency when demand surpasses capacity in hospitals, long-term care facilities, community care clinics, and/or emergency medical services.
